October 3, 2023 Page 2 quantify the change in each respective component during each period; and discuss the reasons for the increases or decreases in the specific dollar amounts for each of the components identified. We note in your proposed disclosure 2. that you perform translation for income and expense items using the average exchange

rate for the next

financial year. Please tell us how this policy complies with the guidance in ASC 830 or, if accurate, revise your disclosure to clarify that your translation of income and expense items uses an average exchange rate for the periods presented in the consolidated financial statements. Refer to ASC 830-10-55-10 and 55-11. General We note that you responded to prior comments 1, 2, 4 and 7 with a 3. statement that you will make the requested changes in future filings. Provide us with an example of the responsive disclosure to each comment in your response to this comment letter.
